They indicate their physical location as **4019 Timber Ridge Road, Sacramento, CA 95814, USA**.

### Services and Claims

- They claim to offer quality medicines and excellent service, describing themselves as “your reliable online pharmacy.” [americascript.com](http://americascript.com)
- They have a “Customer Satisfaction Guarantee” page stating that they are a “top online pharmacy” and promise best medicines and service. [americascript.com+1](http://americascript.com+1)
- Their shipping policy indicates they use carriers like FedEx and USPS, and that choosing FedEx gives options for overnight or prompt delivery. [americascript.com](http://americascript.com)

### What catches the eye (and raises questions)

- On their “Trending Products” list are items like “Hydrocodone 10/325 mg”, “Oxycodone 20 mg”, “Roxicodone 15 mg”, etc. [americascript.com](http://americascript.com) These are controlled substances in

many jurisdictions (e.g., in the U.S.), which raises regulatory/legitimacy questions about how prescriptions are handled, whether these particular medications are legally shipped, etc.

- While they claim to be a licensed pharmacy, I was **not** able from publicly accessible sources to verify accreditation by a recognized U.S. regulatory body (for example, the U.S. state board of pharmacy or the National Association of Boards of Pharmacy (NABP) Verified Internet Pharmacy Practice Sites (VIPPS) program).
- The broader domain of online pharmacies involves known risks: counterfeit drugs, uncertain sourcing, improper dispensing, etc.

## What to Do If You Use Their Service

If you choose to engage with AmericaScript (or any online pharmacy), you may want to take the following precautions:

1. Ensure you have a **valid prescription** from a licensed healthcare provider for all prescription medications.
2. Examine whether the pharmacy requires upload of prescription, checks by a licensed pharmacist, and provides contactable pharmacy staff.
3. Verify that shipping and packaging are secure, and that medication labels are clear, correct, and lawful.
4. Be aware of your local laws: importing prescription drugs from out-of-state or overseas may be restricted or illegal.
5. Monitor for side effects or unexpected packaging issues; retain records of your purchase in case follow-up is needed.

A: Their shipping policy states that they use FedEx and USPS, and customers choosing FedEx can take advantage of overnight or prompt delivery. [americascript.com](http://americascript.com)

**Q4: What if I am unhappy with my purchase?**

A: AmericaScript has a “Customer Satisfaction Guarantee” stating they are committed to providing best medicines and service. [americascript.com](http://americascript.com) You should check their terms for returns, refunds, and what happens in case of errors or adverse reactions.
