- Interventional pain procedures or nerve blocks (when indicated)

Avoid websites or services that:

- Advertise **Dilaudid without a prescription** or "no prescription required."
- Lack a physical address, pharmacist contact, or accreditation.
- Use unsecured pages (no HTTPS) or suspicious payment requests.
- Offer unbelievably low prices or bulk opioids with no checks.
  Purchasing from such sources risks counterfeit, contaminated, or incorrect-dose products and legal consequences.

## Q: Can I get Dilaudid via telemedicine?

A: Possibly — many jurisdictions allow telehealth consultations and prescriptions, but rules vary. A valid clinical evaluation is still required.
